
International Travel Security: Considerations for the LGBTQIA+ Community













Crucial Direction from API

Safety-mission critical travel only

All international travel must be coordinated with the API **prior** to making **any** travel arrangements!

Unofficial International Travel

- Requirements
 - Security Executive Agent Directive 3 (SEAD 3)
 - Government Furnished Equipment Prohibited
 - Some destinations require other agency approval
- Recommendations
 - Travel Advisory & Smart Traveler Enrollment Program (STEP)
 - Training courses
- Combined with Official



Unofficial International Travel

- ➤ Security Executive Agent Directive (SEAD) 3 applies to:
 - ☐ Special-Sensitive-Top Secret (TS) clearance with SCI access
 - ☐ Critical-Sensitive-Top Secret (TS) clearance
 - Noncritical-Sensitive-Secret (S) clearance
- Unofficial International Travel
 - all clearance levels and sensitive positions
 - the most reported activity
 - reported through SEAD 3 Reporting Tool
 - 14 days in advance
 - Post-travel reporting required under certain circumstances
